Qualifications of the award nominees will be judged on the following:

- X **Sustained outstanding civil engineering performance in the public sector**
- X **Evidence of high character and professional integrity**
- X **Civic and humanitarian activities (community service)**
- X **A minimum of 15 years in public service as a civil engineer**
- X **Five of the 15 years shall be at the senior administrative level**
- X **Currently employed in the U.S. public sector at the time of application submittal**
- X **Participation in ASCE**
- X **Letters of Recommendation**

Nominees will be reviewed by the Life Members of the Phoenix Branch, Arizona Section of ASCE and will be confirmed by the executive board of the Phoenix Branch.
